Meeting Minutes May 13, 2023

The regular meeting of the Towamencin Chapter was held at Wentz United Church of Christ, 3246 West Skippack, Lansdale, PA.

The meeting was called to order at 10:30 AM by Regent Suzanne Johnston. Recording Secretary, Donna Alleborn, was present.

32 Members, 6 Prospective Members and 7 guests were present. A quorum was present.

Treasurer Report

Patricia McCormick seconded the motion. The motion passed with all in favor and no discussion.

Regent Johnston reported that the Bylaw Committee is recommending additional changes to our by laws. These changes would assure that the chapter's financial activities align with the DAR's guidance and compliance with IRS regulations. Diane Hustead, Chair Bylaw Committee, will be hosting a Zoom meeting on May 23, 2023 at 7 PM to explain the changes. A copy of the proposed changes will be sent to members at the beginning of June. Members will be able to discuss and vote on this at the June meeting.

Flag Committee

A great time was had by all. The committee will also be visiting Springfield Elementary School on June 2 and North Wales Elementary School on June 16.

Regent Johnston gave a presentation on the history of the American Flag addressing the Sons of Liberty Flag of 1767 to the Grand Union flag of 1775 to present day.

Michael Moran and the Scouts gave a special presentation on the proper way to fold the American Flag and the meaning of each fold. Mr. Moran noted that the community can give their damaged flags to the scouts for proper disposal.

Community Classroom Committee

Our chapter promoted National Teachers Appreciation Week by delivering trays of cookies to General Nash Elementary, Spring-Ford Elementary, Oak Park Elementary, Pennbrook Middle School, North Wales Elementary and Abington Friends School.
